Location: Cass County Fair Grounds

1. These shows will be an official ADGA shows and ADGA rules shall govern the conduct of the shows.
2. The following breeds shall be sanctioned by ADGA. Nubian, Nigerian Dwarf, LaMancha, Recorded Grade, Toggenburg, Oberhasli, Sable, Alpine, Saanen this will also be the show order. The Junior and Senior does shows are separately sanctioned. Class orders are not subject to change. Show order will be Senior does, Showmanship, and Junior does.
3. No horned goats will be allowed to show.
4. Base date for both junior and senior does will be May 12th 2018.
5. Entry fee will be \$5.00 per animal per ring and \$5.00 per pen including tack pens if post marked by May 3rd. If postmarked after May 3rd, entry fees will be \$6.00 per animal per ring and \$6.00 per pen. No refunds of entry fees will be allowed unless notified by May 10th.
6. **All fees must accompany entry form.** Make checks payable to **Cass County Goat Club.**
7. The original registration certificate is required for any animal 6 months old or older. No copies will be accepted, animals without proper papers will not be allowed to show.
8. The original registration certificate or stamped duplicate application showing date received by ADGA office is required for animals under 6 months of age. No copies will be accepted, animals without proper papers will not be allowed to show.
9. All out of state animals must carry an official health certificate from their state of origin. Health certificate must be dated no more than 30 days prior to the show date. Indiana herds do not require a health certificate but all animals will be checked before unloading.
10. Animals may arrive after 4:00 p.m. on Friday, May 11th, 2017. Animals coming in on Saturday morning must be penned by 7:00 am. All paper work must be done by 7:45 am. The show for Ring A will start at 8:00 am. Ring B will start as soon as the first breed is completed and will proceed uninterrupted unless the same breed is being shown in both rings.

12. Restrooms will be available. No camping hook ups will be available.

13. The Cass County Goat Club, Cass County Fair Board or any member of the Fair Board will **NO T** be responsible for any loss, damage or accident of to any person, animal or property.

14. Exhibitor or family member not acting in an honorable manner will be asked to leave the fairgrounds and not return for the remainder of the show.

1. Milking Yearling under 2 years of day of show
2. Milking Doe 2 years and under 3 as day of show
3. Milking Doe 3 years and under 4 as day of show
4. Milking Doe 4 years and under 5 as day of show
5. Milking Does over 5 years as day of show
--Champion and Reserve Champion of each breed

6. Champion Challenge

--Best Milking Doe of Senior Doe

Showmanship

7. Beginners Showmanship- Under 10 years of age day of show (Ring A)
8. Junior Showmanship 10-12 years of age day of show (Ring B)
9. Intermediate Showmanship 13-15 years of age day of show (Ring A)
10. Senior Showmanship 15-18 years of age day of show (Ring B)

Junior kids

11. Junior kid- kids born on or after April 1st. of current year

12. Intermediate kids- born March 1st to March 31st of current year

13. Senior kids- born January 1st to February 28th of current year

14. Junior Yearling (never fresh) born May 1st to December 31st of pervious year

15. Senior Yearling (never fresh) born on or before April 30th of pervious year and under 2 years.
