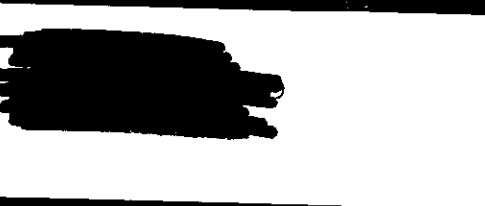

The Indiana Dairy Goat Association met on Sunday, October 3, 2010 at Moral Township Fire Dept. President Jerry Lubbehusen called the meeting to order at 2:40 p.m. Officers present were: President Jerry Lubbehusen, Vice President Rob Smith and Secretary Bonnie Robbins. Directors present were: Chris Hudson and Diana Hubbard. Indiana State Fair Rep Teena Spear was also present.

Due to Judy Hill moving out of state, treasurer records were brought to the meeting for the new treasurer. Election of officers for President, Secretary and Treasurer was held with Jerry Lubbehusen continuing as president; Bonnie Robbins continuing as Secretary and Marianne Ingle being elected as Treasurer. New directors will be David Ingle, Patty Baker and David Spear. Discussion was held regarding the Youth Committee. New head of the Youth Committee will be Chris Hudson. Past youth reps are automatically members of the youth committee. If any other member is interested in being on the committee, contact Jerry or Chris. The youth rep presentations will be in March with all members present voting on the youth rep. Announcement of the youth rep & runner up will be made the morning of the Hoosier Classic.

Jerry asked for volunteers for a committee to come up with a handout for members to use when giving presentations to 4H clubs, schools, etc. Patty Baker & Bonnie Robbins will be on this committee.

Rob reported the Hoosier Classic for 2011 will be held at Wayne Co Fairgrounds on June 11 and 12. Rob is beginning to contact potential judges for the show. Rob also announced this will be his last year as chairman for the show. If anyone is interested in taking on this role, please contact Rob or Jerry. This individual can work with Rob this year to "learn the ropes" and take over for 2012.

Teena gave an update on the State Fair. For 2011 the show will be held in the swine barn; dates are not known yet. Nigerian Dwarfs will be on exhibit again in 2011. The show rings for 2011 will be larger. A new show schedule will be developed to facilitate getting the show done earlier on Sunday of the show. 2011 is the third year of the trial for extended fair. After the 2011 fair a decision will be made on whether to continue the extended fair.

Moral Township Fire Department notified Jerry that they will be raising the rental rate beginning in January by a considerable amount. It was decided to either find a new place to meet or move the meetings around. If any members have a suggestion for meeting places, please pass this information along to an officer or director.
